#### **CANCELLATION POLICY:**

In the event that the exhibitor must cancel this agreement, written notice must be received and the following charges will apply:

- Before January 17th, 2022 Total less 20% administration fee.
- AFTER JANUARY 17th, 2022, NO REFUNDS WILL BE PROVIDED.

#### Circumstances beyond one's control:

Neither party shall be liable to the other party nor be deemed to have breached or violated this Agreement for failure or delay in performing or enforcing any condition of this Agreement to the extent and during the term, of this default or delay is caused by or results from causes beyond the control of the affected party, including, if not limited to, fires, earthquake, floods, embargoes, war, acts of war (whether war is declared or not ), acts of terrorism, insurgencies, riots, civil unrest, strikes, lockouts or other labor disturbances, acts of God, pandemics, omissions or delays in the action of any government authority or the other part.

In the event of an event beyond one's control, a credit note will be provided and funds will be applied to the next event. If the exhibitor wishes to be refunded, any transaction costs incurred will be deducted from the refunded amount. Refunds can take up to 90 days to process.
